### 6. <u>City Councillor's Reports</u>

### Cllr Horrill highlighted

- The Local Plan Part II had been reported sound by the Planning Inspectorate. There was now a six-week period in which the Plan could be challenged by developers. With the government still wishing to build further new homes the Plan would be need to be revisited in 2021. It was noted that Eastleigh County Council did not have a Local Plan in place and neighbouring councils had a duty to support each other in meeting new housing requirements. Sparsholt was protected by its building envelope.
- On Friday 24 and Saturday 25 March, the local community were invited to the Central Winchester Regeneration Community Planning Weekend to help create a Vision for the future of this prominent part of the city. This was previous known as the Silver Hill area.
- Cllr Horrill had attended a "topping out" ceremony to mark the completion of a major phase of Chesil Lodge the City Council's latest extra housing scheme on Chesil Street. The development would make another 52 houses available for older Winchester residents
- In response to concerns about parking in Winchester Cllr Horrill explained changes to car parking charges taking place to increase the difference in price between city centre car parks and those further out while freezing prices of park-and-ride tickets to encourage drivers to use the car parks most suited to their visit. The aim was for people making longer visits to park outside the centre. Whilst the Sparsholt side of the city lacked park and ride facilities a small park and ride should be opened at the north end of Barton Farm sometime next year and there was potential for a further space at John Moore Barracks.
- A Parish Council Forum meeting was to take place on 6 April hosted by Julie Pinnock, Head of Development Management. Sue Wood would attend.
- City Council Tax for the 2017/18 year had been raised by just under £5. With a hole in the budget it was essential to
  generate revenues through projects such as Station Approach and the Leisure Centre and all assets were being
  reviewed.
