Irene Francis Minns 8th April 1931 – 6th October 2015

Irene Francis Minns passed away on the 6th October 2015, at the age of 77 years.

In the entrance of the Memorial Hall there is a photograph taken at the official opening in 1982. At the time Mr John Minns was chair of the Memorial Hall Committee and Irene, his wife, is seen standing next to him. They had both worked tirelessly, for many years, to raise funds for the Hall and its future. Irene assisted John initially but became the Caretaker, in her own right, in 1994. She remained a reliable and conscientious caretaker for 14 years, maintaining excellent relationships with all Hall users. Irene retired from her post in 2008.

Irene was a fairly shy person but she was not slow in voicing her opinion if she felt it was warranted and as a result she contributed greatly to the "discussions" which have always followed the Hall around.

Most of all though, she loved her family and had many a celebration, in her own Memorial Hall. Her love of the Hall and of Sparsholt is exemplified by the fact that any donations in memory of Irene should be used to benefit the Hall. A suitable memorial is being considered.

Sparsholt Parish Plan

Further to the last article, the Parish Plan Working Group has now completed its assessment of how to gather the views of the Residents in the Parish.

The result of that assessment is that the views will be sought in two phases.

The first phase will be on Housing Needs to update the last survey done some 12 years ago. This will take the form of a questionnaire issued one to each residence and these will be issued in the first week of January to be returned by 1st February.


The second phase will be in two parts and both will cover all aspects of life in the village and where relevant, aspects from the first phase. The first part will be issued and addressed to all adults living in the village and the second part will be addressed to all 11 – 17 year olds. We expect this to be issued in March next year.

The aim is to have completed the Parish Plan by the end of 2016 and present the results to the Village at the Annual Parish Meeting in April 2017.

This is a unique opportunity for everyone in the village to have their say in the future of the village and you are all strongly encouraged to complete and return the questionnaires in good time.

Planning

The Winchester District Local Plan Part 2: Development Management and Site Applications Publication Draft is now available. This has been published for consultation for a period of six week from 6th November until noon 21st December 2015. The Plan, supporting documents and online form for comments can be downloaded from: www.winchester.gov.uk/planning-policy/local-plan-part-2. The Plan shows the settlement boundary ("building envelope") area for Sparsholt as below together with protected open areas and conservation areas. The building envelope is unchanged.

Sparsholt Village Design Statement is about the character and qualities of the village of Sparsholt. It sets out guidelines which all developments, building works and changes in the village need to follow to conserve and enhance these character and qualities and to ensure that what is done is in keeping with its surroundings. It sets out guidelines on such things as roof lines, size of new buildings, street signs and furniture, and trees and hedges. This Statement is a Supplementary Planning Document which supplements the Local Plan and forms part of the Local Development Framework for Winchester District. The guidelines must be taken into account when planning applications are considered. A copy of the statement is available on the Parish Council website. The Parish Council meets monthly (normally the third Thursday) and welcomes all to come along and talk about planning.

Highways

The County Council is asking residents' views on a number of proposed changes to the way some environmental work on Hampshire's highways is carried out, namely: street light dimming, reducing the amount of times each year grass is cut along the highway, and reducing the amount of times each year treatments are carried out to kill weeds along the highway.

PLEASE BE ALERT

Two nasty scams to be aware of as highlighted by the police and Neighbourhood Watch coordinator, Jan Anderson.

On Thursday, 29th October, an 88 year-old man from the Sparsholt area of Winchester was contacted by someone pretending to be from 'Hammersmith Police'. The caller claimed they had two males arrested in relation to fraud and that they had the victim's bank details. The victim was asked to go to his bank and withdraw £4,000 that would be fake money, not actually coming from his own account. The victim did not do this and no money was handed over.

On 6th November a gentleman who lives in Dean was offered tree services at excess cost. Money was withdrawn from the bank in preparation for the work to be completed the next day. After hearing about this the home help phoned the man offering tree services (who had a leaflet with no address, no landline, only a mobile number) saying that his services were not required. Unfortunately he turned up the next day was quite threatening and menacing. The police were called. No work has been carried out nor money exchanged. Trading standards have been notified.
