Well done everyone and thank you for taking part – we hope you enjoyed decorating your tree we certainly enjoyed looking at them.



















Health Services across Hampshire and the Isle of Wight

Pressure on the NHS, including current and projected occupancy - All health services across Hampshire and Isle of Wight continue to be **stretched but functioning** relatively well at present but this may change as the situation intensifies. Significant staffing challenges due to an increase in COVID-19 related illness amongst staff and unavailability means the NHS continues to be under greater operational pressure. Critical care capacity across HIOW is at "surge" levels. It is likely that the surge in capacity will require staff redeployment, cancellation of elective activity where appropriate and mutual aid through inter-regional transfers stepping up to support patients.

University Hospital Southampton - reassurance regarding text messages

University Hospital Southampton NHS Foundation Trust is reassuring patients who are waiting for a procedure that they are proactively contacting them by text message, phone call or letter and that it is not a scam. This is in recognition that patients may be concerned about the current delays in treatment and the Trust is asking them to select the statement that best reflects their current situation.






Winchester City Council Waste and Recycling Collections in Sparsholt

Place the tree by your garden waste sack on your collection day weeks commencing 11 and 18 January 2021. Large trees over five feet tall will need to be cut into smaller pieces to enable them to fit in the collection vehicle.






Winchester City Council are moving to a new garden waste collection service, starting on 1 February 2021.

HAM GREEN

Phase 1 of the felling of trees diseased by Ash Dieback has now been completed, apart from 2 large trees which need to be felled into the adjacent fields. However, this will probably not be done until the end of February, when the fields will be empty of crops and the surface will hopefully be firmer.

Most of the Phase 1 felling has been done along the section of footpath from Woodman Lane down to the grass area near the footbridge. Unfortunately, due to the amount of rain recently, the ground became very soft and has been rather badly damaged by the machinery needed to remove the felled trees. As soon as the ground has become firmer, we will arrange for this section of footpath to be repaired but, until then please be careful when using this pathway.

During the November Work Day, part of the Group tidied up in the main felling area and had a really nice (safely spaced) bonfire to dispose of the residual brash. The remainder of the Group worked further down at the Glade Area, where they removed a small Ash tree and made a second log bench from a previously felled Goat Willow tree - both of these activities are shown in the photos below.







The January Work Day is scheduled for <u>Saturday 9th January 2021</u> and, we may have to change our way of working to comply with the latest Covid restrictions.

A Message from Reverend Jax Machin

Dear Friends,

I pray this finds you all well, having safely celebrated Christmas, and that your families are also thriving? I know our thoughts and prayers have been with Charlotte and her family on the sad news of her mother's death.

[Editor's note: Charlotte Nash lives in Chilbolton and is a Licensed Lay Minister, a key member of the Downs Benefice Ministry Team. She sometimes takes Sunday Services and Funerals in St Stephen's Church and leads the Benefice Morning Prayer (via Zoom) on Tuesday mornings at 9.30am.]

On Christmas Day, we had two services in the Benefice, at Sparsholt and Littleton. In the other three parishes, Churchwardens had agreed with my discernment that there were insufficient people able to open the churches or operate services safely within Coronavirus regulations. Accordingly, services in Chilbolton, Crawley and Wherwell were cancelled. For the same reasons, the Benefice Patronal Festival at Sparsholt on Sunday was also cancelled.

Going forward, our Benefice is now placed in Tier 4 of Government restrictions. People are advised to stay home unless absolutely necessary.

Legally, however, in Tier 4 we are allowed to 'leave home to attend or visit a place of worship for communal worship...'

However, over Christmas there has been a sharp rise in new variant cases of Coronavirus. According to the Hampshire Chronicle for 26th December:

THE Winchester district has seen the highest daily number of reported cases since the height of the first lockdown in the spring.
