22/23 - 43 WeCAN

Stuart Mills from WeCAN (Winchester Climate Action Network) is to talk and answer questions on local community action on climate change.

At the request of the Chair this item was brought forward in the agenda.

Stuart Mills gave an informative overview of both WeCAN and Winchester Action on the Climate Crisis (WinACC), Cllr Cooper posed the questions raised by Councillors which included areas such as the national gas grid, ground source heat pumps and listed buildings. A local climate change cafe session for residents to share ideas and find willing volunteers was suggested.

Both our City and County Councillor outlined support available from WCC and HCC to ensure that bona fide information is available to safeguard residents.

22/23 - 46Affordable Housing Update/Parking Consultation

The letter below had been distributed to residents of Woodman Close regarding the parking:

WOODMAN CLOSE, SPARSHOLT - RESIDENT PARKING SCHEME Having reviewed the documentation relating to the previous consultations, I have concluded that there was no (overwhelming) support for the scheme proposed in Nov 2020 to provide additional parking around the Green at Woodman Close and at Stockwell Place.

I am aware that there are ongoing issues relating to parking provision and I will be using the information gathered previously to develop a new scheme to address those issues. Council Officers and our agents will be on site over the coming months to evaluate possible options and I hope to be able to share detailed proposals with you by the end of November. I would like to reassure you that residents will be consulted on any new proposals before any scheme is taken forward.

I look forward to working with the community, Parish Council and Ward members to ensure that any future proposals provide adequate provision, consider residents views and are appropriate to the character of the area.

The Affordable Housing programme is on hold subject to finding a phosphate mitigation programme. It is hoped that the housing work can start in 2023.

b. Smaller Authorities' Audit Appointments (SAAA) - External Auditor Appointment Scheme Under the Local Audit (Smaller Authorities) Regulations 2015, SAAA is responsible for appointing external auditors to all applicable opted-in smaller authorities, for setting the terms of appointment for limited assurance reviews and for managing the contracts with the appointed audit firms.

The next 5-year appointing period runs from 2022-23 until 2026-27 and SAAA has undertaken a procurement exercise to appoint auditors to each County area from 1 April 2022. There is the option to opt-out of the central procurement and appointment scheme and appoint our own external auditor for the next 5-year period, although the process is onerous for smaller authorities.

To continue as part of the SAAA sector led auditor appointment regime no action is required.

Councils unanimously agreed to opt-in and take no further action.

c. Sparsholt sign – insurance claim

The total cost for the purchase and installation of the replacement Sparsholt sign was £243.88. The insurance excess is £250. Councillors unanimously agreed that no insurance claim is necessary.

- d. Grant requests from Victim Support and Citizens Advice Winchester
 - Sparsholt Parish Council has received grant requests for £150 from Citizens Advice Winchester and £50 from Victim Support. Both organisations have provided an explanation of why they are requesting a grant and statistics of the number of parishioners that they have assisted over the year. Action: Clerk

Councillors approved the grant payments to VS and CAW.

- e. Publications Schedule and Records Management Policy/Retention Scheme Sparsholt Parish Council's Publication Scheme was last reviewed in May 2015. The Clerk is to make suggested updates and circulate to the finance group prior to the November meeting. Action: Clerk to review and circulate
- **Fete Donation**

The playground and Ham Green both received donations of £625 from the Sparsholt fete. The £625 received for HamGreen has already been allocated to Tree Guards for the new trees. After discussion the council agreed that the playground donation is to be put towards the repair and repainting of the toddler swing, which has previously been identified as in need of attention. The Clerk is to let the fete committee know where the playground grant is to be spent.
